O R D E R

1. This Court *vide* order dated 11.11.2024 while issuing notice in the transfer petition and considering the application (IA No.255872/2024) for maintaining anonymity of parties and deletion of names from cause title, had directed the Registry to mask the identity of both the parties.

2. Consequent upon the order dated 20.03.2025 passed by this court granting decree of divorce to the parties and disposing of the transfer petition, the Registry was directed to prepare a decree accordingly.

3. Pursuant to the decree drawn by the Registry, an application has been filed by the applicant-

respondent seeking clarification and directions for proper decree drafting without redaction of identities of parties as the redacted decree is causing practical difficulties in its implementation and use before the statutory and other authorities. The prayer of the applicant-respondent was allowed by the Court on 27.04.2026.

4. By office report dated 22.05.2026, the Registry has sought necessary directions.

5. Considering the above, this Court is of the view that the ends of justice would be served by modifying the earlier directions of anonymization to a limited extent.

6. Accordingly, the order directing redaction/ anonymization shall stand modified insofar as relates to the order-sheets, memo of parties, decree to be issued to the parties. The Registry is directed to prepare and issue order-sheets, memo of parties and decree incorporating the actual names and particulars of the parties for their use before competent authorities.

7. It is clarified that the anonymized version of the orders available on the judicial record and in

the public domain shall continue to remain unchanged unless specifically ordered otherwise.

8. Miscellaneous Application is accordingly disposed of.
