O R D E R

1. Leave granted.
2. Interlocutory Applications for impleadment of persons and application for transposition of Respondent No.29 as Petitioner, stand allowed.
3. These appeals emanate from the common judgment and order dated 06.12.2023 passed by the High Court¹ by which the Division Bench allowed the Letters Patent Appeals (LPAs) preferred by the Bihar Staff Selection Commission (the 'Commission') and set aside the judgment dated 03.03.2021 passed by the learned Single Judge. The Appellants have also assailed the validity of the order dated 14.12.2021.
4. Facts giving rise to filing of these appeals in a nutshell are that the appellants were appointed on different dates between 2005 and 2010 on contract basis to the post of Lab Technician/X-ray Technician in Government Medical Institutions. The recruitment to the said post was

governed by Bihar Lab Technician Cadre Rules 2014. On 21.06.2015, the Commission published an advertisement for regular appointments to the post of Lab Technician/X-ray Technician. The prescribed qualification was a Diploma in Medical Laboratory Technology (DMLT).

5. The appellants participated in the aforesaid selection process. The appellants possessed a Bachelor Degree in Medical Laboratory Technology (BMLT) i.e., the higher qualification. However, during the counselling process undertaken by the Commission, the appellants were apprised of the fact that they do not have the requisite qualification, namely the Diploma. Being aggrieved, the appellants, approached the High court by way of filing a Writ Petition, which was disposed of on 30.06.2016 with a direction to the Commission to determine the eligibility of candidates based on the validity of recognized degree/qualification and to consider the candidates possessing valid higher qualification.

6. In compliance of the aforesaid direction, the Commission permitted the appellants to participate and completed the counselling process. On 29.05.2020, the result for regular appointment was published which did not include the names of the appellants.

7. The appellants, thereupon, again approached the High Court. The learned Single Judge of the High Court by an order dated 03.03.2021, directed revision of the merit list and reconsideration of appellants' inclusion in the said list. Being aggrieved, the Commission preferred a series of Letter Patent Appeals before the Division Bench. The Division Bench by an order dated 06.12.2023 set aside the judgment and order dated 03.03.2021 of the learned Single Judge and allowed the Letter Patent Appeals. In this factual background, these appeals arise for our consideration.

8. We have heard learned counsel for the parties at length.

9. The view taken by the Division Bench is in consonance with the law laid down by this Court, namely:

(i) on a post intended for candidates possessing lower qualification, permitting candidates of a higher qualification would result in depriving the genuinely eligible and deserving candidates²;

(ii) that the selection process must be held in consonance with the rules in-vogue at the time when the selection process had commenced and the rules of a game cannot be

changed after the game is played³.

Therefore, we are not inclined to interfere with the judgment of the High Court.

10. However, we cannot lose sight of the fact that the appellants have rendered service as Lab Technician/X-ray Technician in Government institutions for more than fifteen years. It is not in dispute that 610 posts are yet to be filled up. Considering the long period of services provided by the appellants, interest of justice would be subserved if a direction for regularization of the services of the appellants is issued. We accordingly issue the following directions:

A. The State Government shall formulate a scheme for regularization of the appellants to the post of Lab Technician/X-ray Technician and shall regularize the services of the appellants.

B. The appellants shall neither be entitled to the benefit of seniority nor to the benefit of pay-scale of the post of Lab Technician/X-ray Technician for the period prior to their regularization.

C. The period of service rendered by the appellants shall

be reckoned for the purposes of the pension, if the post of Lab Technician/X-ray Technician is otherwise pensionable.

D. Liberty is granted to the State to decide whether the appointment of the appellants to the post of Lab Technician shall be treated as an extra cadre contractual appointments or within the cadre.

E. The interim order dated 05.02.2024 directing the parties to maintain *status quo* is vacated.

F. The State is granted liberty to fill up remaining vacant posts.

It is clarified that these directions are issued in the peculiar facts and circumstances of the case and are confined to the appellants before this Court.

11. Accordingly, the appeals are disposed of.
