1. Sri Ashutosh Pandey alias Ashutosh Brahmachari appeared (through video conferencing). Sri Vinay Sharma, Sri Gaurav Kumar, Sri Ashvaneer Kumar Srivastava, learned counsel for the plaintiffs no. 3 to 5, Sri Bipin Kumar Jaiswal, Sri Sandeep Kumar Agrahari and Ms. Reena N. Singh (through video conferencing) appeared on behalf of the plaintiffs.

2. Ms. Tasneem Ahmadi and Sri Mehmood Pracha through video conferencing, Sri Tanveer Ahmad Khan and Sri Imran, Sri Afzal Ahmad, Sri Azim Ahmad Kazmi, Sri Hare Ram Tripathi, appeared on behalf of defendants.

3. In view of previous order of this Court, the report of District Magistrate and S.S.P. Mathura, in sealed cover has been received. This Court has gone through the report and considered that the arrangements have been made by the administration pertaining to the alleged Kar Seva and for keeping security at the premises. The report is classified and therefore, again kept in sealed cover.

4. Learned counsel for the plaintiff seeks further time to file objections to

application no. 141 Ka 1 to cure the inadvertent defects and file an amended/additional written statement after curing the inadvertent defects set out in para no. 3. Allowed further time to file objections.
