ORDER

1. The applicant- Mr. Birender Sangwan has filed Original Application complaining about illegal cutting of trees and damage to the boundary wall of the park and air pollution caused by the construction activities

carried out in violation of environmental norms.

2. The above said OA was disposed of vide order dated 25.01.2024.

Since the directions given by this Tribunal were not fully complied with,

the matter was listed before the Tribunal by registering M.A. No.

1

129/2024 on which notices were issued to the respondents for filing their compliance reports.

- 3. Reply dated 04.04.2025 was filed by respondent no. 4 that environmental compensation amount of Rs. 3,00,000/- has been deposited with DPCC vide three separate Demand Drafts no. 004148, 004149, and 004150 dated 02.05.2024 for amount of Rs 1,00,000/- each.
- 4. Reply dated 14.07.2025 has been filed by respondent no. 1- PWD. Costs of Rs. 10,000/- have been deposited by PWD with Registrar of this Tribunal by bankers cheque no. 044130 dated 07.05.2025. Amount of Rs. 1,00,000/- towards environmental compensation, which was to be deposited with DPCC, has been deposited by Public Works Department vide Demand Draft no. 255504 dated 08.05.2025 with the Registrar of this Tribunal. As per order dated 25.01.2024 environmental compensation amount of Rs. 1,00,000/- was to be deposited with DPCC. The Ld. Registrar General of this Tribunal is directed to take requisite action for transfer of the amount of Rs. 1,00,000/- deposited with the Registrar of this Tribunal through above mentioned demand draft to DPCC.
- 5. DDA has not deposited costs of Rs. 10,000/- imposed vide order dated 07.04.2025. Learned Counsel for DDA has undertaken to deposit costs of Rs. 10,000/- within one month and on such deposit copy of the deposit receipt may be place by the Registry on record of this case.
- 6. DDA has not filed any additional status report but learned Counsel for the DDA has stated that demolished walls have been re-constructed and steps have been taken to restore the park and carry out further plantation in the park.

7. As per order dated 25.01.2024 amount of Rs. 50,000/- was to be

paid to the applicant as costs. Learned Counsel for DPCC has stated that

amount of Rs. 50,000/- has been paid to the applicant by DPCC.

8. In view of the above, no further action is required to be taken on

the present Miscellaneous Application, which is disposed of accordingly.
