At the outset of the proceedings today, an application has been moved on behalf of accused no. 1, 2 and 4 seeking time for four weeks in order to examine the witnesses who have been summoned in the present block of dates.

It is also prayed in the application that the matter may be thereafter be listed only once a week.

Another application has been moved on behalf of accused no. 5, 6 and 14 praying that the evidence for the prosecution be deferred for any date subsequent to 17.11.2025.

Similar oral prayers for adjournment of evidence for the prosecution have been made by the ld. respective counsels for the other accused.

The essence of the submissions is that in view of the short time available between the framing of the charge and the commencement of evidence, the ld. respective counsels would require adequate time to prepare for cross-examination of the prosecution witnesses. It has been further submitted that the order on charge is itself required to be studied in detail for a more effective cross-examination.

Mr. Maninder Singh, ld. Sr. Counsel for A-1 to A-4 has pointed out that he recently suffered a bereavement in his family and

has only returned to India a few days back. The Ld. Sr. Counsel has however gracefully expressed that his prayer for adjournment is nevertheless upon the grounds akin to others and not necessarily his above personal loss.

While the above prayers are opposed on behalf of the CBI, a prayer is made that evidence may be commenced today.

The court deems it appropriate that a copy of these applications be provided to the CBI which is at liberty to file a reply.

For the present, the court deems it fit that since witnesses from out of Delhi are present today, an effort be made to examine them in chief.

PW1 Sudipta Nandi has been examined-in-chief.

Any objections pertaining to the documents tendered during the examination-in-chief can be taken by the ld. Counsels for the accused persons when PW1 is recalled for cross-examination.

After PW1 has been examined-in-chief, the ld. Sr. Counsel on behalf of the CBI has submitted that witness Ashok Singh, also present today, may be permitted to be examined along with PW1 when he is next recalled for cross-examination.

The above prayer is allowed.
