O R D E R

Learned counsel for the respondent(s) has sought for  
some time to file counter affidavit.

We have heard learned senior counsel for the  
petitioner and learned senior counsel for the first  
respondent-State and learned counsel for the second  
respondent.

Pending consideration of this Special Leave Petition, we find that this is a fit case where interim bail ought to be granted to the petitioner herein who is aged about twenty three years as of now since he has been in jail for over nine months (since 07.08.2024) and charges have not yet been framed till date.

In the circumstance, we direct that the petitioner be produced before the concerned Trial Court as early as possible and the Trial Court shall release him on interim bail subject to such conditions as it may deem appropriate to impose to ensure his presence in the proceedings arising out of FIR No.406/2024 dated 19.07.2024.

However, the petitioner shall extend complete cooperation in the ensuing investigation. The petitioner shall not misuse his liberty in any manner.

The petitioner shall not make any attempt to contact the second respondent-prosecutrix in any manner whatsoever.

Any infraction of the aforesaid conditions may entail in cancellation of the interim bail and rejection of the Special Leave Petition.
