- 1. Allowed, subject to all just exceptions.
- 2. Application stands disposed of.

- 3. The present petition has been filed by the petitioner seeking the following prayers:
 - a) Issue a writ of mandamus or any other appropriate writ/order/direction directing the Respondents to take immediate and effective measures to draft a policy to curb this menace,
 - b) Direct Respondents to deploy at least Six traffic officials at the stretch of intersection Josip Broz Tito Marg and Siri Fort Road, and place atleast Two Traffic official near Arun Jaitley Park, at-least Two Traffic official near Indian Oil Petrol Pump and at-least Two Traffic official





near Panchsheel Enclave Gate No. 3, to prevent the violations of traffic rules on Josip Broz Tito Marg and Siri Fort Road;

- c) Direct the Respondents to install some trees or barriers on the central channel so that wrong-side driving vehicle do not collide with other vehicles;
- d) Pass such other or further orders as this Hon'ble Court may deem fit in the interest of justice, public safety, and equity."
- 4. The petitioner is the Resident Welfare Association (RWA) of Panchsheel Enclave, New Delhi and is primarily aggrieved by rampant and un-checked illegal wrong-side driving at the intersections of Josip Broz Tito Marg and Siri Fort Road, Delhi.
- 5. Learned senior counsel on behalf of the petitioner submits that despite having brought the issue of traffic violation and wrong side driving at the said intersection to the notice of the respondent no.4/Deputy Commissioner of Police (Traffic), South Zone, Delhi Police by way of various representations, no action has been taken till date.
- 6. Learned senior counsel further submits that there exists a genuine apprehension that a major mishap might occur on account of rampant disregard of the traffic rules.
- 7. Issue notice.
- 8. Learned counsel, as aforesaid, accepts notice on behalf of the respondents.
- 9. Let reply be filed within a period of four weeks. Rejoinder thereto, within a period of two weeks thereafter.
- 10. In the meantime, the respondent no.4 shall deploy adequate number of traffic officials at the stretch and intersection of Josip Broz Tito Marg and Siri Fort Road, Delhi. Further, traffic officials shall also be deployed near





Arun Jaitley Park; near Indian Oil Petrol Pump and near Panchsheel Enclave, Gate No.3, to prevent violation of traffic rules, as highlighted in the present petition.

- 11. Let a status/ compliance report be filed by the respondents before the next date of hearing.
- 12. List on 21.01.2026.
