Upon perusal of the said instructions, it is observed that there is no specific direction to the department to mention the caste and religion of the minors kept at the Rajkiya Balgrih (Balika), besides other instructions with respect to the order dated 16.9.2025 passed by this Court in Application U/S 482 No.31545 of 2024 (Praveen Chetri v. State of U.P. and another). It is further noted that the information recorded in the departmental records has been kept confidential, and such information is utilized solely for the rehabilitation of the minors.
3. In view of the instructions received and the material produced before this Court, the Director and the Secretary of the Directorate of Women Welfare, Uttar Pradesh are directed to appear through video conferencing tomorrow to assist the Court about the requirement of caste and religion in the details prepared by counselors and the office of District Probationary Officer of the minors who have been kept in the Rajkiya Balgrih (Balika).
4. The date and time have been fixed as per the convenience of the officers, after deliberations with them by Shri Sarvajeet Singh, DPO, Prayagraj.

1. Heard learned counsel for the petitioners and learned A.G.A. for the State.
2. The present writ petition has been filed seeking issuance of a writ, order or direction commanding the respondent-authorities to produce the corpus, namely Sunita, stated to be the minor sister of petitioner no.2, allegedly kept in illegal custody of respondent nos. 4 to 9.
3. On earlier dates, this Court had expressed concern regarding the mentioning of caste and religion of the minor children kept at Rajkiya Balgrih (Balika), despite specific directions issued by this Court in Application under Section 482 No. 31545 of 2024 (Praveen Chetri v. State of U.P. and another).
4. On the last date of hearing, learned A.G.A. placed before the Court a letter dated 02.12.2025 issued by the Special Secretary, Government of Uttar Pradesh, addressed to the Secretary, Ministry of Women and Child Development, Government of India, containing suggestions for amendment in the relevant provisions of the Juvenile Justice (Care and Protection of Children) Act, 2015 and the Juvenile Justice Rules, 2016.
5. Learned A.G.A., on instructions, further submits that the corpus is presently in the safe custody of her brother, who is arrayed as petitioner no.2 herein. In view thereof, no useful purpose would be served in keeping the present petition pending.
6. Accordingly, the instant writ petition stands disposed of.
