ORDER

1. In this Original Application, the complaint of the applicant is about operation of the dyeing units without consent/NOC/permission at Bindapur, Matiala, Ranhola, Khyala, Meethapur, Badarpur, Mukundpur&Kirar in Delhi in violation of the environmental norms.
2. The DPCC has filed action taken report dated 20.05.2025 disclosing that the joint inspection was carried out by MCD, BSES, SDM Office, DJB and DPCC on 08.04.2025, 07.05.2025 and 08.05.2025. In the joint inspection, 22 locations, the geo-coordinates of which are mentioned, were examined and following status was found:-

“5. That fresh joint inspection was carried out by MCD, BSES, SDM Office, DJB and DPCC on 08.04.2025, 07.05.2025 & 08.05.2025 on the basis of complaints received from public. 22 premises/locations have been inspected by the joint team and details are as follows:

3. Learned counsel for the applicant submits that the geo-coordinates mentioned in second column of the above table are not correct and the applicant had supplied different geo-coordinates on 28.02.2025 and 03.03.2025 to the concerned CMC Cell of DPCC and on those geo-coordinates no inspection has been carried out. She further submits that even two days ago, fresh inspection was done but the details have not come on record.

4. Learned counsel for the applicant is permitted to file objection to the action taken report of the DPCC dated 20.05.2025 disclosing the full details of the geo-coordinates and locations which were supplied by the applicant to the respondent-DPCC and further material to support the plea that the proper inspection has not been carried out.

5. Let the same be filed within a period of four weeks.

6. Respondent-DPCC is also permitted to file the additional report within six weeks.
