<u>LETTERS DATED 03.02.2021 AND 22.3.2021 OF LEARNED REGISTRAR</u> <u>GENERAL, HIGH COURT OF DELHI IN W.P.(CRL.) NO.120 OF 2012</u>

At the outset, Mr. R.S. Cheema, learned Senior Counsel, submits that it would be appropriate to appoint two Special Courts for disposal of the matters in question since they are about 41 in numbers.

Mr. Tushar Mehta, learned Solicitor General appearing for the respondent-Union of India, agrees to the aforesaid suggestion.

We consider it appropriate to nominate Mr. Arun Bhardwaj and Mr. Sanjay Bansal as Presiding Judges of Special Court Nos.1 and 2 respectively. They shall be appointed in the order of their seniority.
