# ORDER (Made by the Hon'ble Chief Justice)

Reports have been filed, inter alia, by the Animal Husbandry Department indicating the release of funds by the Hon'ble Governor and by the State to feed stray animals, abandoned horses and even elephants during the lockdown.

2. It is submitted on behalf of the Committee appointed by an earlier order of this Court that paltry amounts have been apportioned on a district-wise basis and an amount of Rs.9,000/proposed to be allotted to some of the districts may evaporate even before reaching the districts. It is suggested that the drive to feed the stray dogs and cats be restricted to urban areas for it to make a meaningful impact. It is also pointed out on behalf of the Committee that there should be a correlation between the money allotted to a particular area and the number of requests received from such locality.

3. It is heartening that both the Hon'ble Governor and the State have released funds for a noble cause as promptly as they https://www.mhc.tn.gov.in/judis/

have. Indeed, the Hon'ble Governor released funds without there being a request from the Court and before the State released funds. The funds released by the Governor helped in the initial feeding, particularly of stray dogs and cats in and around this metropolis. It is hoped that private parties, including some prominent corporate houses, chip in with money or material to ensure that the voiceless do not suffer during the lockdown.




