Leave granted.

We have heard learned counsel for parties.

We have no doubt that the matter in issue is a serious one and the offence is also heinous. However, we are faced with a position where the appellant, amongst other accused, has been in custody for eight and a half years. The prosecution evidence is over and so as also the statement to be recorded of all the accused under Section 313 Cr.P.C. The appellant before us has already made a statement through the counsel that he does not propose to lead any defence evidence. Thus, insofar as the appellant before us is concerned, the case is ready for hearing. However, in view of the large number of accused in the case, that is not the position for all the accused as some of the accused seek to lead defence evidence.

On consideration of the matter, we are of the view that pending the trial we cannot keep a person in custody for an

indefinite period of time and taking into consideration the period of custody and that the other accused are yet to lead defence evidence while the appellant has already stated he does not propose to lead any evidence, we are inclined to grant bail to the appellant on terms and conditions to the satisfaction of the trial Court.

The appeal accordingly stands disposed of.
