PROGRAMME IN THE ELECTRONIC AND PRINT MEDIA AND TO MAKE ANY SUCH PUBLICATION AS COGNIZABLE OFFENCE WHICH WILL HAVE A REASONABLE PUNISHMENT AND ETC.,

THIS PETITION COMING ON FOR ORDERS THIS DAY, **SACHIN SHANKAR MAGADUM J.**, MADE THE FOLLOWING:

**ORDER**

The captioned writ petition is filed to issue a mandamus to respondent No.1 to frame statutory rules to prevent publishing of indecent, obscene, violent, sexual video, audio and images. A mandamus is also sought to direct respondent No.1 to prevent electronic media from analysing the sub-judice matters and also a direction against respondent No.2 not to leak information collected during the course of investigation.

2. The respondent/State by memo dated 10.06.2021 placed on record circulars and instructions issued to the police force in the State regarding providing information of investigation to the press and media. This Court having taken judicial note of the circulars vide order dated 15.06.2021

however directed the respondent/State to initiate appropriate proceedings against the erring police officials and also issued appropriate directions to the police in terms of the circulars which are placed on record.

3. In compliance of the order dated 15.06.2021, the respondent/State has filed a memo on 12.08.2021 reporting compliance of order dated 15.06.2021.

4. We have given our anxious consideration to the directions issued by the respondent/State to the police officers not to disclose information regarding details of cases under investigation. The directions are detailed at clauses (a) to (f) of circular dated 11.08.2021.

5. Learned counsel for the petitioner fairly submits that the prayers made in the writ petition are duly complied by the respondent/State.

6. In view of compliance by the respondent/ State, we would find that there is substantial compliance. In terms of the circular issued by the respondent/State, the police officers who are in-charge of the investigation are hereby directed to strictly adhere to the instructions incorporated in the circular dated 11.08.2021.

7. In view of the circular dated 11.08.2021 issued by the Government of Karnataka, nothing survives for consideration in the present writ petition. Accordingly, the writ petition stands disposed of in terms of the aforesaid observations.

The pending interlocutory applications, if any, stand disposed of.
