This appeal takes exception to the judgment and order dated 04.08.2017 passed by the High Court of Judicature at Hyderabad for the State of Telangana and the State of Andhra Pradesh in Criminal Revision Case: Crl.R.C. No. 943 of 2017. The High Court dismissed the revision application filed by the appellant questioning the order passed by the First Appellate Court rejecting the application for condonation of delay of only 37 days.

The grievance of the respondents is that the appellant offered different explanation before the First Appellate Court and the High Court. That, however, does not take the matter any further. The question is whether the delay of 37 days in filing of the appeal against the acquittal of accused Nos. 2 to 5 can be said to be uncondonable?

In our opinion, as it is not in dispute that the appeal against conviction of accused No. 1 against the selfsame decision is pending before the First Appellate Court, it would be in the interest of justice that the delay of 37 days in filing the appeal before the First Appellate Court against acquittal of accused Nos. 2 to 5 is condoned.

Accordingly, this appeal succeeds and the impugned judgment and order passed by the High Court is set aside. The delay in filing of the appeal before the First Appellate Court stands condoned.

The appeal filed by the appellant against the acquittal of accused Nos. 2 to 5 is revived, to be heard along with appeal against the conviction of accused No.1 before the same Court.

The First Appellate Court is directed to expeditiously dispose of both the appeals.

The appeal is disposed of in the above terms.
