Further to our earlier order affidavits on behalf of a large number of schools detailing the default and the amount due in payment of school fees are filed before us and taken on record.

We are informed by learned counsel that a special leave petition against our order dated 1st October, 2021 has been filed before the Supreme Court and is awaiting consideration.

Dr. Indrajit Kundu, learned advocate representing a group of schools submits before us that on the pretext of alleged default in the payment of school fees, students are not being allowed to avail of online classes and their admit cards to appear in the board examination is being withheld.

We only observe that by our earlier orders, which are still continuing, we had directed that pending resolution of the various contentions raised before us, the students should not suffer and that online classes should be continued to be provided to them, no student should be expelled on the ground of non-payment of fees and that admit cards and results should not be withheld on those grounds. We reiterate those directions subject to any order that may be passed by the Supreme Court.

We are disturbed to read the supplementary affidavit affirmed on behalf of Adamas International School in December, 2021, inter alia, to the effect that first information reports are being generated by the police and action threatened on complaints made

concerning non-payment of school fees, expulsion of students etc. and a recommendation has been made by the West Bengal Commission for Protection of Child Rights on 2<sup>nd</sup> December, 2021 on more or less the self-same complaints.

We observe and direct that when complaints are received by any authority touching the subject matter of this litigation, any contemplated action should and can only be taken with the leave of this court.

On the prayer of Mr. Sabyasachi Chowdhury, learned advocate appearing for the Birla group of schools, we observe that schools which have started physical classes may proceed with it on such terms and conditions as the school may set subject to consideration of the issue on the returnable day of these applications.

As the matter is awaiting consideration before the highest court, we adjourn the applications before us till 17th December, 2021 when it is to be listed at 2.00 P.M., without deliberating on any other matter.
