This public interest litigation has been filed to seek a direction on the respondents to ensure adequate food security to rural population through subsidies on Diesel, Petrol and Kerosene for farmers engaged in mechanized farming in the State of Tamil Nadu.

2. A representation dated 02.11.2021 was made by the petitioner before filing the writ petition, wherein he had prayed for reduction of the price of Diesel, Petrol and Kerosene for the use of machinery and vehicles used in the agriculture and agro-based

> 3. The prayer made in this writ petition does not come under the judicial scrutiny, as the aforesaid prayer comes within the policy decision of the Government and for that a direction in the nature as sought by the petitioner cannot be granted. It is upto the Government to frame a policy for grant of subsidies on Diesel, Petrol and Kerosene.

> 4. In view of the above and finding that this court has no jurisdiction to issue direction on the respondents to take a policy decision to ensure adequate food security to rural population through subsidies on Diesel, Petrol and Kerosone engaged in mechanized farming in the State of Tamil Nadu, the writ petition is dismissed. No costs.
