Heard Shri Sudhir Mehrotra, learned counsel for the contemnor, Shri Abhishek Pandey holding brief of Shri Shadab Ali, learned counsel for the opposite party.

The contemnor-Vikram Sharma is present in the court. He has been produced from Naini Central Jail, Prayagraj. Learned counsel submits that an affidavit seeking unconditional apology has been filed by the contemnor vide application dated 4.3.2022, the same may be accepted and the contemnor be discharged.

Shri Sudhir Mehrotra, learned counsel for the High Court has opposed the prayer and submits that it is not a genuine apology having regard to the conduct and demeanour of the contemnor.

We have perused the report and the order sheet, contemnor-Vikram Sharma is called upon to answer the following charge:-

1. You-Vikram Sharma wrote and dispatched a letter dated 15.12.2016 in the form: 'Show Cause notice vs. Shri Ali Zamin', the letter was addressed to the Hon'ble Prime Minister, Hon'ble the Chief Justice of India, Chief Minister of Uttar Pradesh and Hon'ble the Chief Justice of Allahabad High Court, wherein you alleged that in the District Court all the Judges, Officers and employees are dis-honest, they have murdered the Constitution of India. You presented yourself as a representative of 125 crore Indians.

2. You-Vikram Sharma, further alleged that your colleagues named in the letter were tortured and the same complaint was sent on 2.1.2017 to the Senior Superintendent of Police for legal action against the dignitaries addressed to. An extract of the letter

dispatched by you makes the following allegations.

**"Beimano Ne Meri Awaj Ko Kuchalane Ke Liye Mujhko Aneko Pran Ghatak Hamle Karayen Hain, Jisase Apni Satya Nyay Jaan Ki Raksha Ke Liye Prarthana Patra Registered Dak Se Bheje Hain, Jisake Sare Sakshya Mere Pas Hain Aur Aapke Hain. Dinank 30.4.2014 Ko Mere Upar Smast Beiman Judges, Adhikariyon, Karmachariyon Ne Nayayalaya Ke Karyalay Me, Thane Main Chikitsalaya Mein Pranghatak Hamala Karaya... Mare Katla Hua Sambidhan Ka Mrit Sarir Mujhe Saupa Jaye, Jisase Mai Anteyesththi Vidhi Vidhan Se Kar Saku..., Atah Aap Notice Prapti Ke Ander 7 Din Karan Spast Karein Ki Jis Sambidhan Ki Hatya Apke Dwara Ki Gayi Hai, Uss Sambidhan Ki Mrit Sarir Se Mahamari Na Faile, Ki Antyeshthi Dinank 1.1.2017 Ko Ki Jaye...."**

3. You-Vikram Sharma further stated in the letter that Constitution of India shall be buried on 1.1.2017 and its ashes shall be sent to the responsible murderers.

Notice need not be issued to the contemnor as he is present in the court. The charge shall be served upon the contemnor and a copy thereof be supplied to the learned counsel.

The contemnor undertakes to file the reply within four days.

Put up the matter on **4.4.2022**. On the said date the contemnor shall be produced before the court by the Jail Authorities. The Jail Authorities shall permit the learned counsel to contact the contemnor in jail as per rules.

Learned A.G.A to inform the Jail authorities for compliance.
