This petition coming on for order this day, **JUSTICE VIVEK RUSIA** passed the following:

#### **ORDER**

The petitioner i.e. Shivneri Sahil Empire Rahwasi Rakhrakhav Sahakari Sansthan Maryadit Indore has filed the present petition in the nature of Public Interest Litigation (PIL) seeking shifting of location of liquor shop situated at Scheme No.140 running by the respondent No.5.

According to the petitioner, the said shop is running just infront of Agrawal Public School where thousands of boys and girls are studying and the distance of liquor shop from the school is 22-25 meters whereas amended Rule 2 of Rules 2018 prohibits that no shop for the sale of liquor shall not be situated upto a distance of 50 meters from lawful religious institution, girls school, girls college and lawful girls hostel. According to the petitioner, in the Agrawal Public School, the students from nursery to 12th are studying and timing of school is 08:00 AM to 05:00 PM. The liquor shops opens at 09:00 AM and due to the similar timing and proximity of the distance, it is causing nuisance in the society and locality. The petitioner's society made complaint to CM Helpline but no action has been taken. On 05.06.2022, the Chief Minister of Mahdya Pradesh has declared that a new liquor policy will be introduced soon wherein no liquor shops will be allowed within 252 meters of areas from where women and girls schools are there.

### Heard.

So far as locus of the petitioner is concerned, the petitioner is association of local residents and entire policy and Rules 2018, there is no such prohibition for establishment of liquor shop nearby the residential area and so far as Rule 2 is concerned, it is exclusively applies to lawful religious institution, girls schools, girls college and lawful girls hostel. It is not the case of the petitioner that Agrawal Public School is exclusively girls school. Even otherwise, Agrawal Public School is having any grievance, they can file petition before this Court but petitioner cannot file a petition at the instance of Agrawal Public School for seeking shifting of the shop. So far as religious institution is concerned, it is defined under Explanation-(b)- "Religious Institution" means an institution for the promotion of any religion and includes temple, math, mosque, church or other place of public religious worship which is managed or owned by a public trust registered under the Madhya Pradesh Public Trusts Act, 1951 or any other enactment for the time being inforce and shall include such other religious institutions as the State Government may by order specify in this behalf. The temple situated within the campus of the school or established by the Agrawal Public School cannot said to be a religious institution under Explanation-(b).

In view of the above, this Writ Petition is misconceived and is hereby dismissed.
