**CRL.M.C. 4654/2022 , CRL.M.A. 18837/2022 (interim relief)**

Petition has been preferred on behalf of the petitioner under Section 482 Cr.P.C. for quashing of FIR No.116/2020, under Sections 109/114/147/148/149/153A/323/392/395/427/436/454/505/120B/34/ IPC and Sections 25/27 of Arms Act registered at Police Station: Khajuri Khas, Delhi and the proceedings emanating therefrom.

Issue notice. Learned SPP for the State/R1 appears on advance notice and accepts notice.

Reply be filed before the next date of hearing with an advance copy to the learned counsel for the petitioner.

Respondent No.2 be served by all permissible modes on necessary steps being taken by learned counsel for the petitioner, returnable for 25.01.2023.

An application for stay of proceedings has also been preferred by the petitioner on the ground that multiple FIRs stand registered against the petitioner covering the same offences and facts arising from the same cause of action. It is urged that the accused cannot be subjected to fresh investigation by the police in respect of the same incident and the same is in infringement of right of accused under Article 20(3) of the Constitution of India and judgments passed by the Hon'ble Supreme Court.

The application shall be considered in the light of reply reflecting the factual position in the respective FIRs by the respondent/State. No directions for stay of criminal proceedings are passed, at this stage.
