**NIA files Chargesheet against 6 members of proscribed terrorist organization Jamaat-UI-Mujahideen Bangladesh (JMB) in JMB Bhopal Case (RC-11/2022/NIA-DLI)**

Today (07.09.2022), NIA filed a Charge Sheet against 6 accused in NIA Special Court, Bhopal, Madhya Pradesh in the case pertaining to arrest of six active cadres of JMB from Bhopal, including three illegal Bangladeshi immigrants involved in propagating JMB ideology and motivating youth to perform Jihad against India. The case was initially registered as FIR No. 13/2022 dated 14.03.2022 at PS- STF, Bhopal, MP and re-registered by NIA on 05.04.2022.

2. Investigations have established that the accused persons had conspired along with their associates to perform Jihad and commit violent and terrorist acts. They were found provoking the youth to carry out violent Jihad in India for establishment of a Caliphate in order to establish Sharia law.
