



NIA Filed a Charge Sheet against 11 accused in the case related to recovery of Explosives at Nimbaheda, Chittorgarh, Rajasthan (RC-18/2022/NIA/DLI)

1. Today (22.09.2022), NIA filed the Charge-Sheet before NIA Special Court, Jaipur in the case of recovery of Explosives from a Baleno Car at Nimbaheda, Chittorgarh, Rajasthan. The case was initially registered as FIR no. 150/2022 dated 30.04.2022 at PS Nimbaheda and later re-registered by NIA on 20.04.2022.
2. Investigations have revealed that main conspirator in the instant crime, Imran Khan and other co-accused persons, were members of Sufa terrorist gang and had hatched a conspiracy to commit terrorist acts. Investigation has also revealed that they were inspired with ISIS philosophy and activities. In furtherance of conspiracy, they procured arms, ammunition, explosive materials for waging of war and commission of terrorist acts.
3. It has also come to light that accused Imran Khan used to hold meetings and provide training in fabrication and assembling of IED to other co-accused at his farm. On the directions of accused Imran Khan, explosive/IEDs were prepared/assembled by procuring chemicals and other materials from the local market with the support of other accused persons.
