JUDGMENT

THE CASE SET UP BY THE PROSECUTION: -

- **1.** The above-named accused has been charge-sheeted by the police for having committed offences punishable under Section 147/148/149/188/436/452 IPC.
- **2.** Brief facts of the present case are that on 02.03.2020, FIR was registered on the basis of written complaint dated 28.02.2020

(received vide DD No.46-B), made by one Sh. Sanjay Kumar Goyal. Complainant alleged that in the late night of 24.02.2020, a riotous mob had criminally trespassed into his medical shop bearing no. E-251/B, in the name and style of "Goyal Medicos" situated in Gali No.4, Khajuri Khas, Main Karawal Nagar Road, Delhi-110094. Complainant further alleged that bad elements of the society from this mob, had forcefully pored petrol inside his aforesaid shop and set the same on fire. He further alleged that all his furniture and medicines kept inside aforesaid shop were burnt, as a result of which he suffered huge financial loss of Rs. 15 lacs.

- 3. During investigation, SI Vipin Kumar recorded statement of complainant and on the basis of his statement, SI Vipin Kumar added Section 452 IPC in the present case. During further investigation, accused Noor Mohammad @ Noora was identified as one of the members of the mob, which indulged into the riot covering this incident of 24.02.2020. Accordingly, accused was arrested in this case.
- **4.** After completion of investigation, on 30.06.2020 chargesheet was filed by SI Vipin Kumar, before Duty ACMM (North East), Karkardooma Courts, Delhi, against accused for offences punishable under Section 147/148/149/188/436/452 IPC. On 30.01.2021, ld. CMM (North East), Karkardooma Courts, Delhi, took cognizance of offences punishable under Section 147/148/149/436/452 IPC. However, ld. CMM (N/E) declined to take cognizance of offence under Section 188 IPC, for want of complaint under Section 195 Cr.P.C. On 12.02.2021, case was

committed to the sessions court. Thereafter, on 22.12.2021, a supplementary chargesheet along with a complaint under Section 195 Cr.P.C., was filed by SI Deepak Chandra, before ld. Link ACMM (N/E), which was committed to the sessions court vide order dated 06.01.2022.

CHARGES:

5. On 31.08.2021, charges were framed against accused Noor Mohammad @ Noora for offences punishable under Section 143/147/148/454/436 IPC read with Section 149 IPC, to which he pleaded not guilty and claimed trial. The charges were framed in following terms: -

"That in the late night of 24.02.2020, exact time unknown, in the area of E-Block, Khajuri Khas, main Karawal Nagar Road, Delhi-110094, within the jurisdiction of PS Khajuri Khas, you being from a particular community alongwith your other associates (unidentified) formed an unlawful assembly, the object whereof was to cause maximum damage to the property and persons belonging to the other community and commit criminal trespass and arson in the shops, houses and other properties of the persons from other community by the use of force or violence in prosecution of the common object of such assembly and thereby committed offences punishable under Section(s) 143/147/148 IPC read with Section 149 IPC and within my cognizance.

Secondly, on the aforesaid date, exact time unknown, at shop No.E-251/B (by the name of "Goyal Medicos"), Gali No.4, Khajuri Khas, main Karawal Nagar Road, Delhi-94, you being member of said unlawful assembly in furtherance of your common object alongwith your other associates (unidentified) committed lurking house-trespass in the said shop/medical store, belonging to complainant Sanjay Kumar Goyal, S/o Shri Maniram Goyal, to commit offences and thereafter committed mischief by fire or explosive substance with the intent to destroy the aforesaid shop and thereby committed offences punishable under Section(s) 454/436 IPC read with Section 149 IPC and within my cognizance."

6. Thereafter, on 20.07.2022, additional charge was framed against accused Noor Mohammad @ Noora for offence punishable under

Section 188 IPC, to which he pleaded not guilty and claimed trial. The charge was framed in following terms: -

"That, in the late night of 24.02.2020 in the area of E-block, Khajuri Khas, main Karawal Nagar Road, Delhi-94, within the jurisdiction of PS Khajuri Khas, you being member of an unlawful assembly alongwith your other associates (unidentified) was present at aforesaid place, in prosecution of the common object of such unlawful assembly and in violation of the proclamation issued u/s 144 Cr. PC by the competent authority/DCP, North East vide order dated 24.02.2020 bearing no.10094-170 X-1, North East, Delhi dt.24.02.2020, which was duly announced in all the localities of District North East and, thereby you committed offence punishable under Section 188 IPC and within my cognizance."

DESCRIPTION OF PROSECUTION EVIDENCE

7. Prosecution examined 10 witnesses in support of its case, as per following descriptions: -

PLEA OF ACCUSED UNDER SECTION 313 CR.P.C.

- **8.** Accused Noor Mohammad @ Noora denied all the allegations and pleaded innocence, taking plea that he was falsely arrested in case FIR No. 221/20. He further took plea that complainant and Ct. Rohtash wrongly identified him in the police station on 02.4.2020. He further took plea that he was falsely implicated by the police in the present case and contents with respect to his identification are false. He further took plea that this is a false case which has been slapped upon him to work out the same. He opted not to lead any evidence in his defence. Thereafter, DE was closed and matter was fixed for final arguments.
- **9.** I heard ld. Special PP and ld. defence counsel for accused and I have perused the entire material on the record.

ARGUMENTS OF DEFENCE & PROSECUTION

Mohammad @ Noora argued that complainant/PW9 did not identify accused Noora. He further argued that PW10/Ct. Rohtash was witness of identification of accused, however, point out memo Ex.PW10/D-1 shows that PW10 had already seen accused on 01.04.2020 i.e. prior to his identification in this case on 02.04.2020. But PW10 did not divulge involvement of accused in the present case on 01.04.2020. He further argued that statement of PW10 and identification of accused by PW10 on 02.04.2020, were apparently an after though story. He further argued that there is no credible evidence on the record against accused in the present case. He further argued that site plan itself mentioned a different property number.

11. Per contra, Ms. Simran Chawla, Adv. appearing for Sh. R.C.S. Bhadoria, ld. Special PP for State argued that PW9/Sh. Sanjay Kumar Goyal proved burning of his shop. She further argued that PW10/Ct. Rohtash proved identification of accused as member of mob. She further argued that prosecution proved commission of incident and identification of accused, in the present case.

APPRECIATION OF FACTS AND EVIDENCE

UNLAWFUL ASSEMBLY & RIOTS

12. Testimonies of PW1, PW2, PW9 and PW10 mention about a mob consisting of more than 5 persons, which indulged into vandalism and arson in the area covering E Block, Khajuri Khas, Delhi on 24.02.2020. The evidence of PW5, PW9 and PW10 further establishes that medical shop being run by PW9 was in fact burnt. The photographs Ex. PW9/P3 read with certificate Ex. PW9/C also confirm that this shop was burnt. The factum of an unlawful assembly committing riot has not been challenged by the defence. Therefore, I have no hesitation to conclude that there was an unlawful assembly which used explosive/inflammable substance to burn the shop of PW9.

IDENTIFICATION OF ACCUSED

13. The foremost question is that whether accused Noor Mohammad @ Noora was also involved in the aforesaid incident, as a member of above-mentioned unlawful assembly? To establish identity of accused as member of above-mentioned mob, prosecution produced two witnesses i.e. PW9 and PW10. However, PW9/complainant turned hostile to the case of prosecution and deposed that incident at his shop did not take

place in his presence. Therefore, he did not identify the accused as member of the mob, which set his shop on fire. Such testimony of the complainant was in deviation to the allegation made in his complaint Ex. PW9/A. This complaint was written by PW9 himself. He alleged in this complaint that he was present in his shop and a mob forcefully trespassed into his shop and set it on fire. Be that as it may be, the fact remains that PW9 did not identify the accused as rioter.

14. Next witness is PW10/Ct. Rohtash. This witness in his examination in chief stated that he was on duty near Lakhpat School and at a distance of about 15 meters from shop in question. He saw a mob setting this shop on fire on 24.02.2020 after 10 AM. He had identified some faces in that mob. Subsequently, on 02.04.2022, he saw IO/SI Vipin interrogating a person in the police station. At that time PW10 identified that person and informed IO that said person was involved in the riots in E block, Khajuri Khas on 24.02.2020. He came to know name of that person as Noor Mohammad from the IO. During his cross examination, PW10 deposed that after riot and before 02.04.2020 he did not see accused at any place. However, on being confronted with a pointing out memo prepared in FIR221/20 of same police station, on 01.04.2020, PW10 admitted that it was signed by him. As per this pointing out memo Ex. PW10/D1, SI Sandeep had prepared it in the presence of PW10 and accused herein had allegedly pointed out E-4 Khajuri Khas to SI Sandeep and PW10 on 01.04.2020. Thus, this memo shows that PW10 had already seen and met accused prior to 02.04.2020. Still, PW10

did not divulge to SI Sandeep that accused was also involved in

the incident at Goyal medicos. Thus, identification by PW10

becomes doubtful evidence and it is not safe to rely upon the

same. Thus, I do not find credible evidence to show that accused

was part of the mob, which set the shop of PW9 on fire.

CONCLUSION & DECISION

15. In view of my foregoing discussions, observations and findings, I

find that charges levelled against the accused in this case are not

proved beyond reasonable doubts. Hence, accused Noor

Mohammad @ Noora is acquitted of all the charges levelled

against him in this case.
