Reply to the bail application filed by investigating officer.

Arguments at length advanced by Ld.counsel for the applicant/accused and Ld. Addl. PP for the state are heard.

This is the bail application under Section 439 Cr. PC moved on behalf of applicant/accused Yu Zhang.

**Brief facts:** The present case is stated to be registered on the complaint of victim Sh. Rohan Kapoor. It is stated that the complainant got a SMS containing link for 3<sup>rd</sup> Covid dose vaccine loan on his mobile phone. After necessary formalities and downloading the mobile application Express Loan, the complainant got loan of Rs.4200/- in his bank account. After four days of getting the loan, the complainant started receiving threatening calls from express loan and they also sending the morphed nude images of the complainant to his contacts. That despite paying the loan amount, the complainant was receiving extortion calls. Case was registered and during the course of investigation, location of mobile number 7309045632(from which the threatening calls were received) was

traced and raid was conducted. Accused Zuhaib Hassan was found to be using the said mobile phone and he was arrested in the present case. The accused Zuhaib Hassan was found to be running telecalling centre unauthorized instant loan application namely rupee way. The accused Zuhaib Hassan received a sum of Rs.12,534/- and Rs.11,227/- for the alleged recovery from Boris Fintech Pvt. Ltd./Diwali Rubby and the applicant/accused Yu Zhang was found operating the said company.

It is submitted by Ld.counsel for the applicant/accused that the applicant has been falsely implicated in the present case and she is in JC since 20.09.2022. that the applicant/accused is an employee of alleged Boris Gaming Company and the applicant was not aware that the funds sent to Funzone for development purposes, were being misused and used for extortion purposes. That there are no allegations of image morphing in the charge sheet. That the investigation qua the applicant/accused is already complete and no fruitful purpose is going to be served by keeping the applicant/accused in JC when the other accused persons have already been released on bail. That the applicant belongs to respectable family and having clean antecedents. It is prayed that the applicant/accused may kindly be enlarged on bail.

On the other hand bail application is strongly opposed by Ld. Addl. PP for the state.

I have considered the submissions made by Ld.counsel for the applicant/accused and Ld. Addl. PP for the state.

The applicant/accused is in JC since 20.09.2022. The applicant/accused is not alleged to have made any extortion calls. There is no material to show that any picture has been morphed or sent by the

accused. Charge sheet has already been filed. The applicant is not required for any custodial interrogation. Trial is going to take long time and no useful purpose is going to be served by keeping the applicant/accused further in JC.

Considering the facts and circumstances of the case, period of custody already undergone, the fact that the applicant/accused is not required for any custodial interrogation, I am inclined to allow the present bail application under Section 439 Cr. PC moved on behalf of applicant/accused Yu Zhang. **The applicant/accused Yu Zhang is admitted to bail on furnishing bail bond in the sum of Rs.50,000/- with one surety in the like amount to the satisfaction of Ld. Trial Court/Ld.CMM/MM/Duty MM** and subject to the following conditions:

**(a) The applicant/accused shall furnish to the Investigating Officer/ S.H.O., a cell phone number on which the applicant may be contacted at any time and shall ensure that the number is kept active and switched-on at all times;**

**(b)The applicant/accused shall not tamper with evidence nor otherwise indulge in any act or omission that is unlawful or that would prejudice the proceedings in the pending matter;**

**(c) The applicant/accused will not leave the country without prior permission of the court concerned.**

With these observations the bail application moved on behalf of applicant/accused **Yu Zhang** is disposed off.
