#### **ORDER**

### **C.M.** Impleadment Application:

- 1. Learned counsel for the applicant submitted that the prayer made in this application be restricted only to the extent of impleadment of M/s Pancham Realcon Pvt. Ltd. as one of the respondents in the writ petition, as certain interim orders passed in the present petition filed in public interest are adversely affecting the interest of the company.
- 2. To that extent, no objection has been raised by the learned counsel for the petitioner.
- 3. The application is allowed to the above extent.
- 4. Let M/s Pancham Realcom Pvt. Ltd. 10, L.S.C. Kalkaji, New Delhi through its Authroized Signatory Ajay Mishra be impleaded as respondent No. 19 in the array of parties.
- 5. Office to carry out necessary correction in the memo of parties.

# C.M. Impleadment Application No. 16806 of 2018: C.M. Stay Vacation Application No. 16876 of 2018:

- 6. These applications have been filed by the allottees of the plots, villas and flats allotted by M/s Pancham Realcom Pvt. Ltd. seeking impleadment; and, vacation of the orders dated March 28, 2011 and April 22, 2011.
- As an application filed by M/s Pancham Realcom Pvt. Ltd. for being impleaded as respondent has been allowed vide order of date, we do not deem it appropriate to allow these applications, as the impleaded company will take care of the interest of the allottees as well.
- 8. The applications are rejected.

### On main petition:

- 9. Supplementary affidavit, filed today on behalf of the petitioner in the Court, is taken on record.
- 10. Learned counsel for the petitioner has raised an issue regarding the arrangement being made for Magh-Mela which is to start from January 14, 2023.
- 11. The issue was raised with reference to plastic bags and bottles being thrown in river Ganga and Yamuna.
- 12. This Court earlier also had touched this issue in the orders passed on October 29, 2021 and November 12, 2021, However, as pointed out by the learned counsel for petitioner, still plastic waste is being thrown in rivers Ganga and Yamuna and the drains in the city are chocked with that. Many of the drains are discharged along with this waste in river Ganga.
- Order passed on November 12, 2021 records that the Commissioner, Prayagraj had constituted a Committee consisting of A.D.M. City, Prayagraj, Additional Municipal Commissioner, Nagar Nigam, Prayagraj and Superintendent of Police (City), Prayagraj to oversee implementation of the ban on plastic carry bags in pursuance of the Government Order dated July 15, 2018. However, as pointed out by the learned counsel for the petitioner at the time of hearing, no effective steps have been taken to stop use of plastic for which the order was issued on July 15, 2018.
- 14. Learned counsel for the respondents sought time to apprise the Court about the present status.
- 15. We deem it appropriate to constitute four teams of young lawyers present in the Court including law students studying in different

law colleges who are on the internship in Court, to make survey regarding implementation of the aforesaid orders passed by this Court.

16. We deem it appropriate to appoint following Advocates and students, who have volunteered for the said purpose:
