IPC r/with 120B and 149 IPC.

Accused Tariq Moin Rizvi, Jagar Khan, Mohd. Illiyas, Khalid Saifi and Umar Khalid are directed to furnish bond u/s. 437-A Cr.P.C. in the sum of Rs.10,000/- with one surety in the like amount.

Copy of order be sent to Jail Superintendent concerned for intimation to concerned accused persons.

Put up for framing of charge and admission denial of documents on 17.12.2022. Issue production warrant for accused Mohd. Tahir Hussain, Khalid Saifi and Umar Khalid, for next date.
