*This petition coming on for heraing this day, JUSTICE ROHIT
ARYA passed the following:*

ORDER

Petitioner; an energetic young lawyer, has raised a public cause as a

social activist by filing the instant voluminous petition with a grievance that there are encroachers on forest land particularly in compartments PF-1 and PF-2 of *Susera* beat. Due to encroachment, the protected forest area is being exploited illegally causing damage to forest and ecological imbalance. He further submits that he has filed representations Annexures P/6 and P/7 addressed to respondents No.2, 3 and 4 on 30.06.2022 but to no avail.

Shri Mody, on advance notice, assures this Court that if such representations have been filed, the same shall be adverted to and decided. He also submits that the petitioner may also submit a fresh representation seeking indulgence of the Competent Authorities. The suggestion accepted.

Accordingly, the present Writ Petition is disposed of with the following directions:-

- (i) The petitioner may submit a fresh representation **within a week** from the date of passing of this order before the respondents No.2, 3 & 4 in person with acknowledgement.
- (ii) The respondents No.2, 3 & 4 shall be well advised to look into the grievance of the petitioner as pointed out in the representation and decide the same with promptitude.

With the aforesaid directions, the present Writ Petition stands **disposed of**.

It is made clear that this Court has not expressed any opinion on the merits of the case.
