## NIA files Supplementary Charge-sheet against 14 accused persons in a case related to Naxal attack on former MLA Sh. Gurucharan Nayak and killing of two police personnel at Project +2, High School Jhilrua, PS- Goikera, District - West Singhbhum, Jharkhand

Yesterday (31.12.2022), NIA filed a Supplementary Charge-Sheet before NIA Special Court, Ranchi, Jharkhand, in a case pertaining to attack on former MLA, Sh. Gurucharan Nayak and killing of two police personnel by CPI (Maoist) at Project +2, High School Jhilrua, PS- Goikera, District - West Singhbhum, Jharkhand on 04.01.2022.

The case was initially registered as FIR No. 01/2022 dated 05.01.2022 at PS Goikera, Dist-West Singhbhum, Jharkhand and re-registered by NIA on 30.06.2022.

2. Investigations have revealed that the accused persons are members of CPI (Maoist) and they participated in meetings in which a conspiracy was hatched to target former MLA Gurucharan Nayak. They also participated in the crime which resulted in injury and death of police personnel and looting of arms and ammunition.

Investigations

also brought out that the accused persons were involved in recruitment of members for the commission of terrorist acts and organized Training Camps for carrying out terrorist activities.

3. The accused persons chargesheeted under sections 120B, 121, 121-A, 147, 148, 149, 201, 302, 307, 333, 353, 395, 396, 397 of IPC, Sections 16, 18, 18-A, 18-B, 19, 20, 38 & 39 of the UA(P) Act and section 27 of Arms Act are listed below:
