2. The Petitioner is directed to implead all Bar Associations including DHCBA as Respondents in the present Writ Petition
3. The issue in the present Writ Petition relates to holding of a uniform election in one day for all Bar Associations. It has also been brought to the notice of this Court that every lawyer is required to vote in the Bar elections, and therefore there is a necessity for preparation of a proper I.D. Card for lawyers.
