#### <u>ORDER</u>

Leave granted in the Special Leave Petition.

Learned counsel for the parties are assisted by the parties. Though mediation has not been successful, we impressed upon parties and the counsels of a desirability of bringing the usual bouquet of cases in matrimonial disputes to an end. In fact this is an aggravative case where possibly between the parties, there are 21 cases filed by one side or the other!

We appreciate the advice rendered by the counsels to the parties which has been adopted by the parties in Court and they have agreed to resolve all their disputes in the following manner:

1) A decree of divorce dated 24.01.2023 has already been passed by the Additional District Judge, 2<sup>nd</sup> Court, Siliguri, District Darjeeling in Matrimonial Suit No. 60(2)/2018. It is fairly stated on behalf of the petitioner that even though it is a decree of divorce on grounds of cruelty, the petitioner wants to bring this issue to an end and will not assail that judgment in any further proceedings. The said statement is taken on record.

Insofar the permanent alimony 2) as is concerned, there is a child from the marriage, named, Dhairya, who is living with the respondent/mother and would continue to be in her custody. The provision itself has to be made for the permanent alimony for the benefit of the wife and the child. It is agreed before us that a lump-sum amount of Rs. 30 lakhs will be paid by petitioner/husband to the respondent/wife the towards the said purpose within four weeks in full and final settlement of all her claims towards the maintenance, stridhan etc., whatever it be.

3) We now come to the most contentious issue which is before us, the visiting rights, which

gave rise to multiple cases. It is necessary that the child should get the benefit of the affection of both the parents even though the parties have not been able to live together. It appears that on the visiting rights, contentions arise with regard to the visiting process. The visiting right is granted on alternative Sundays between 10.00 a.m. to 5.00 p.m. The child apparently has not met the father for some time and thus an unsupervised visit which is what is proposed but it would be appropriate that initially the interaction between the father and the child is in the presence of a counsellor to be appointed by the State Legal Services Authority at Calcutta. The visitation will be at Siliguri where the respondent/wife resides.

4) On the child being comfortable with the father, unsupervised interaction can take place and in the vacations, the child can be with the father for about a week once the counselLor is of the view that the interaction is taking place in a manner which facilitates such unsupervised interaction for a longer period of time in the vacations.

7) Whatever certificates of the respondent/ wife are with the petitioner/husband, it is assured that they will be returned to the respondent/wife.

We hope that the parties will adopt more cooperative attitude for the purposes of the child even though they have not been able to live together.
