UPON hearing the counsel the Court made the following O R D E R

In purported compliance of the order dated 14.09.2023, 1. learned Additional Advocate General, appearing on behalf of the State of Uttar Pradesh, states that a Committee comprising three officers, which includes one police officer in the rank of Additional Director General of Police, Meerut Zone, has been constituted to examine the cases where the New Okhla Industrial Development Authority (for short, `NOIDA') might have illegally paid compensation in collusion and connivance with the officers of NOIDA and the beneficiaries. Though the said Committee has been nomenclatured as `SIT' but it appears to us that it is essentially a Fact Finding Committee.

2. Let the said Committee immediately look into the records of NOIDA and submit a report to this Court within two weeks.

3. It is made clear that no further time shall be granted for the said purpose.

4. After perusal of the Report to be produced before this Court, the desirability of issuing directions for an independent and fair investigation will be considered on the next date of hearing.

5. Post these matters for hearing on 02.11.2023.

6. Interim protection granted to the petitioners shall continue to operate, meanwhile.
