**ORDER**

1. We had issued a notice upon the respondent vide our order dated 21.11.2023. *Dasti* service was also permitted and the petitioner is filing the affidavit of service upon the respondent.
2. The affidavit of service of notice has been tendered by the petitioner which is taken on record.
3. Nobody appears on behalf of the respondent.
4. It is submitted by counsel for the petitioner that respondent is liable to make the payment of approximately Rs.2 Crores and the respondent is closing down its business and, therefore, it is submitted by counsel for the petitioner that let the respondent be restrained from transferring the properties of the respondent to any other third party during the pendency of this Broadcasting Petition.

5. In view of the aforesaid submissions and also looking to the amount due and payable by the respondent to the petitioner as stated in the memo of this petition which is a sizable amount and also looking to the Annexure P-5 to the memo of this petition, we hereby restrain the respondent from dealing with and/or disposing of or parting with the possession, alienating, transferring or selling or encumbering or creating any third party rights or charges on the movable and immovable properties of the respondent.

6. We also hereby restrain the respondent from creating any further charge upon the properties of the respondent.

7. We hereby direct the respondent to file an affidavit stating the properties of the respondent as on date of filing of this petition which is dated 30.10.2023. This affidavit shall be filed by one of the Directors of respondent.

8. We hereby issue **Bailable Warrant upon the Directors of the respondent** in the sum of **Rs. 5 Lakhs for each of the Directors** of the respondent whose details are as under: -

9. This petition has been filed for the recovery of **Rs.2,02,64,462/-** from the respondent.

10. We hereby issue **Bailable Warrants in the sum of Rs.5 Lakhs upon each of the following Directors whose details are as under:** *Dasti*/Direct service upto Head of aforesaid Police Station(s). The details furnished by the petitioner are as under:
