#### CRL.M.A. 24775/2024 (Exemption)

- 1. Allowed, subject to all just exceptions.
- 2. The application is disposed of.

# CRL.M.A. 22485/2024 (u/S 482 of Cr.P.C., 1973)

- 3. By way of present application, the applicant/petitioner seeks permission to place on record the latest Medical Document dated 29.07.2024.
- 4. Issue notice.
- 5. Mr. Zoheb Hossain, learned Special Counsel appearing on advance notice, accepts notice on behalf of the respondent and submits that he has no objection if the present application is allowed.
- 6. In view of the submission made, the application is allowed and the





Medical Document dated 29.07.2024 is taken on record.

7. The application is disposed of.

## CRL.M.A. 24776/2024 (u/S 482 of Cr.P.C., 1973)

- 8. By way of present application, the applicant/petitioner seeks extension of interim bail.
- 9. Learned Senior Advocate on behalf of the petitioner submits that he does not wish to press this application.
- 10. In view of the submission made, the present application is dismissed as not pressed.

### CRL.M.A. 24774/2024 (u/S 482 of Cr.P.C., 1973)

- 11. By way of present application, the applicant/petitioner seeks early hearing of the CRL.M.(BAIL) 1338/2024 and of the present main bail petition.
- 12. For the reasons and grounds stated in the application, the application is allowed and disposed of.

# CRL.M.(BAIL) 1338/2024 (u/S 482 of Cr.P.C., 1973)

- 13. By way of present application, the applicant/petitioner seeks interim bail during the pendency of the main bail petition on account of his medical condition.
- 14. It is submitted that the petitioner is suffering from life-threatening diseases and he has been recently admitted in the Hospital and the same is evident from his medical documents placed on record.
- 15. The Medical Prescription of Sahai Clinic & Diagnostics vis-a-vis., the petitioner, wherein it has been indicated that on 16.08.2024, the petitioner was brought to the clinic having complaint of breathlessness with cough expectorant, dyspnea exertion and fever and he was referred to get admitted





in emergency. Thereafter, the applicant/petitioner was shifted to Arihant Hospital, Gurgaon, Haryana, wherein he has been advised oxygen and admission.

- 16. It is submitted that the applicant/petitioner is suffering from serious life-threatening medical conditions.
- 17. *Vide* Order dated 12.08.2024, the applicant/petitioner has been granted interim bail by the learned Special Judge (PC Act) on account his wife's medical condition, expiring on 21.08.2024.
- 18. Now, the medical condition of the applicant/petitioner has become precarious. Therefore, the interim bail has been sought on his medical grounds.
- 19. Issue notice.
- 20. Mr. Zoheb Hossain, learned Special Counsel appearing on advance notice, accepts notice and seeks time to verify the medical records of the applicant/petitioner.
- 21. List for arguments on 30.08.2024, the date already fixed.
- 22. Till the next date of hearing i.e., 30.08.2024, the applicant/petitioner is granted interim bail on account of his precarious medical condition, upon his furnishing a personal bond in the sum of Rs. 2,00,000/- and one surety of the like amount to the satisfaction of the learned Trial Court, and further subject to the following conditions:
  - a) Applicant/petitioner shall not leave Delhi/NCR without prior permission of the Court;
  - b) Applicant/petitioner shall appear before the Court as and when the matter is taken up for hearing;
  - c) Applicant/petitioner shall provide his mobile number and also the

mobile number of his wife/surety to the IO concerned, both of which shall be kept in working condition at all times and he shall not change the mobile numbers without prior intimation to the Investigating Officer concerned;

- d) Applicant/petitioner shall inform the IO and the Jail Superintendent the address where he shall be available in Delhi.
- e) Applicant/petitioner shall also inform the IO of the Hospital where he is undertaking the medical procedure for his ailment and shall keep updating the IO on a weekly basis of the treatment undergone by him.
- f) Applicant/petitioner shall not indulge in any criminal activity and shall not communicate with or come in contact with the witnesses.
