- 1. Heard Sri Prashant Chaurasiya, Advocate holding brief of Sri Anurag Narain Srivastava, learned counsel for petitioner as well as learned Standing Counsel for respondents.
- 2. The petitioner has approached this Court seeking a direction to State-respondents to issue or modify certificate / mark-sheet of the petitioner with requisite name and gender change in the same.
- 3. - 4. Owing to the gender change of the petitioner, the same was published in the gazette of Government of India 19-25 August, 2023 and the same was also got published in the leading Newspaper namely Rashtriya Sahara on 28.01.2023. On the basis of the documents the petitioner has moved has moved an application to High School and Intermediate Education, Prayagraj and also to Board of Technical Education, Lucknow for change of name and gender of the petitioner but the same has not been changed and accordingly present writ petition has been filed seeking a direction in this regard.
- 5. To determine as to whether merely on account of FTM Mastectomy surgery (female to male) a person is liable to be considered as a male is an issue which has to be determined by

the State Government / Central Government and some rules or law in this regard ought to be passed. What would be the the factors would determine the gender of the petitioner whether the presence of XX / XY chromosomes or any individual organ of the body which would determine the gender of an individual has to be considered and provided either by the legislature or by the Government by promulgating any enactment or rules. The courts on their parts can only direct the authorities to comply with any law in case they are not following the same or examine any order if it is in violation of any act or rules but this Court would have the power itself to determine the gender of any individual in absence of any enactment or Rules.

- 6. Accordingly, learned Standing Counsel is direction to inform this Court as to whether the State is contemplating passing any legislation or rules in this regard or not.
- 7. List this case on 18.09.2024 in top ten cases.
