O R D E R

Leave granted.

Keeping in view the period of incarceration undergone by the appellant, Neeraj Singal, and as the trial has effectively not commenced, we accept the present appeals.

Accordingly, we direct that the appellant, Neeraj Singal, will be released from jail in connection with ECIR/DLZO-II/06/2019 dated 29.08.2019 for the offence(s) punishable under the Prevention of Money Laundering Act, 2002, in relation to the scheduled offence(s) under Sections 467, 471 and 120B of the Indian Penal Code, 1860 and Section 447 of the Companies Act, 2013, on terms and conditions to be fixed by the trial court.

In addition to the conditions imposed by the trial court, the appellant, Neeraj Singal, shall comply with the conditions mentioned in Section 438(2) of the Code of Criminal Procedure, 1973.

The appellant, Neeraj Singal, will provide a mobile number on which he can be contacted by the Officers of the Directorate of

Enforcement to ascertain his whereabouts and presence. The appellant, Neeraj Singal, will surrender his passport and not leave India without permission of the trial court.

In case there is a violation of any terms and conditions of release, it will be open to the prosecution to seek recall of this order before the trial court.

The impugned judgment is set aside and the appeals are allowed in the aforesaid terms.

We clarify that the observations made in this order are for disposal of the present appeals and the same will not be treated as an expression of opinion on the merits of the case.

Pending application(s), if any, shall stand disposed of.
