The present application has been moved on behalf of applicant Abhishek Gupta seeking regular bail/ extension of interim bail. However, regular bail application has already been pending before this court and therefore, the new application be attached with the old application (No.200/2024).

The matter has been challenged before the High Court of Delhi by the accused on account of imposition of condition of payment of Rs.2.5 crores wherein High Court vide its order dated 29.11.2024 has made the following order:-

"In the meantime, in view of the orders of the Supreme Court in SLP No.14851-14854/2024 titled as Parvinder Singh & Ors. Etc. v. Central

Bureau of Investigation, the direction of learned Trial Court as contained in Para-70 of order dated 23.09.2024 for deposit of Rs.2.5 Crore till 30.11.2024 with Red Cross Society shall remain stayed qua the petitioner.

Also the High Court in the same matter, where owners of the building have approached for grant of regular bail, extended their interim bail till 21.01.2025. The matter of payment of compensation as ordered against the owners, has been stayed by the Supreme Court.

On behalf of victim, Counsel Sh.Abhijit Anand has submitted that they have also filed petition before the High Court challenging the interim bail granted by this court and the same is fixed for 09.12.2024 and interim bail should not be extended. Reliance is placed upon following judgments:-
