% ORDER 24.12.2024

## I.A. No. 49913/2024 (Application for non-compliance of orders dated 05<sup>th</sup> September, 2024 and 22<sup>nd</sup> October, 2024)

1. The present application has been filed under Order XXXIX Rule 2A of the Code of Civil Procedure, 1908 ("CPC") read with Section 11 and 12 of the Contempt of Court Act, 1971 read with Section 151 CPC for non-compliance of this Court's orders dated 05<sup>th</sup> September, 2024 and 22<sup>nd</sup> October, 2024.





2. Learned counsel appearing for the plaintiff submits that vide order dated 05<sup>th</sup> September, 2024, this Court had granted an *ad-interim injunction* in favour of the plaintiff restraining the defendant nos. 1 and 2 from using





the impugned mark AFC,

- 3. It is further submitted that vide order dated 22<sup>nd</sup> October, 2024, defendant nos. 1 and 2 were further restrained from using the impugned domain names i.e., www.afc.world and www.afconline.in.
- 4. It is submitted that despite the injunction operating against the defendants, the defendants are continuing to use the impugned marks on their websites, social media pages, and other third-party websites. It is further submitted that the aforesaid domains are still active.
- 5. Issue notice.
- 6. Notice is accepted by learned counsel appearing for defendant no. 3, who submits that he shall take instructions with respect to the status of the domains.
- 7. Issue notice to the other non-applicants.
- 8. Let reply be filed within a period of four weeks. Rejoinder thereto, if any, be filed within a period of two weeks, thereafter.
- 9. List on 25<sup>th</sup> February, 2025, i.e., the date already fixed.
