## ORDER

- 1. Leave granted.
- 2. The facts of this case in a nutshell are that appellant Nos.
  2, 3, 4 and 5 had filed an application for quashing of the FIR and consequential criminal proceedings arising therefrom. The appellant Nos. 2 to 5 had been arraigned as accused for the offences punishable under Sections 376-D, 385, 420 and 34 of the Indian Penal Code, 1860 and Section 37(a) of the Information Technology Act, 2000. Appellant No.1 being the complainant, had also filed an affidavit indicating her intention not to continue prosecuting the complaint. The High Court, vide the impugned order has dismissed the application

and has accordingly directed the investigation of the case to

be conducted by an IPS Officer.

3. The affidavit filed by the complainant before the High Court,

makes it clear that she is not willing to prosecute the matter

and has completely retracted from the earlier statement made

by her.

4. We have also been informed that the complainant has since

married the appellant No.3 being accused No. 1 and also has a

child with him.

5. In such view of the matter, continuing the criminal

proceedings would amount to a travesty of justice.

6. Considering the above, we are inclined to set aside the

impugned order and quash the criminal proceedings initiated

against appellant Nos. 2 to 5.

7. Accordingly, the impugned order is set aside and the

proceedings in C.R. No. 676 /2021 stand quashed.

8. The appeal is allowed, on the aforesaid terms.

9. Pending application(s), if any, shall stand disposed of.
